SHOW LOCATION: Football Stadium – North Lake Park, Garnett, Kansas.

**RULES:**

1. Each contestant will sing a minimum of 1 song. Judges will score each contestant and narrow the number of participants down to ten (10) people. The final 10 contestants will sing a second song and judges will determine a 1<sup>st</sup>, 2<sup>nd</sup> & 3<sup>rd</sup> place winners.
2. Karaoke and PA equipment, including a library of songs, will be provided by Michael Newberry, Michael Shawn Entertainment. Participants may bring their own music CD. You can contact Michael directly concerning music at 913-375-8682 or email michaelshawnn@yahoo.com.
3. Judging criteria: (1) Connection with audience; (2) Stage presence; (3) Song knowledge; (4) Vocal ability; and (5) How song fits the performer.
4. NOTE: This is a family entertainment event.
  - A) NO MUSIC CONTAINING PROFANE LANGUAGE WILL BE PERMITTED.
  - B) NO ALCHOLIC BEVERAGES OR CIGARETTES, NOR CONTAINERS ADVERTISING ALCOHOLIC BEVERAGES OR CIGARETTES TO BE USED AS PROPS BY PARTICIPANTS.
  - C) Contestants should dress appropriately. NO SHOES, NO SHIRT, NO PARTICIPATE!
  - D) The Anderson County Corn Festival has the right to refuse or reject a participant for any reason deemed necessary.

6. Corn Idol will begin at 10:00 am at the Stadium Stage located at the Football Stadium in the North Lake Park, Garnett, Kansas.
7. Please note: To prevent a repeat winner, the first place winner of the previous year will be ineligible to compete for the current year competition, but will be welcomed back to participate in 2009.
